Appendix 1

Supporting Documentation

To qualify for relief from Import Charges (Customs Duty & VAT) and VRT, you must provide documentary evidence (copies can be used) which establishes categorically that all the conditions set out in the legislation have been met.

To establish ownership or possession of the vehicle:

- You must supply the Vehicle Registration document. This document is also required to register the vehicle in the Republic of Ireland

To establish use of the vehicle:

- You must supply the Certificate of insurance valid for 6 months when arriving from outside the E.U.

To show your transfer to the State:

- When arriving to the State from a country outside of the E.U, (this includes vehicles coming directly from Great Britain and those in transit from GB through Northern Ireland) you must provide evidence showing the date of importation of your effects i.e., ferry tickets, plane tickets, etc.

To establish your residence abroad:

It is necessary for a successful application to provide evidence of living abroad. Typically, evidence submitted would include at least one of the following official documents or statements showing day to day living abroad, for example:

- o *Utility bills in your name, e.g., phone, electricity, gas, etc.*
- o *Documents relating to rental agreements or a mortgage.*
- o *Documents relating to employment or social welfare.*

The above suggested document types are not mandatory, or exhaustive, but it is vital to a successful application that you would be able to provide, if requested, adequate documents to support your claim of day to day living abroad.

To establish your residence in this State:

It is necessary to provide evidence of taking up residence in the State. Typically, evidence submitted would include one of the following:

- *Documents relating to rental agreements or a mortgage, or,*
- *Documents relating to employment or social welfare.*

Depending on the evidence submitted, and the particular circumstances of each individual application, further documentary evidence may also be required to process the claim.
